### Financial Tools and Incentives Subcommittee-Pam McDonough

Evergreen Plaza Associates or its Nominee, 9730 South Western Avenue, Evergreen Park, IL-Application for a Class 7b incentive—The applicant intends to purchase the subject property, substantially rehabilitate and subdivide the 9-story building into multiple suites for parking, office and retail use. #### **Next Level Northwest Presentation**
