or any of its agents or officials, in any suit for damages resulting from accidents to persons or property on account of or as a result of  
such demolition operations shall, when notice of the pendency of such suit shall have been given to said \_\_\_\_\_

This obligation shall not be affected by the fact that the County of Cook has heretofore taken or may hereafter take additional bond
