- II. Presentation: Overview of 2021 Findings on Re-Entry**
 - a. DFSS-Scan Model: Pilot program (11 months in) that provides services in 6 community areas where gun violence is concentrated to youth (ages 14-24) with the highest risk of violence involvement using violence reduction strategies that are trauma-informed, specifically Cognitive Behavioral Therapy (CBT)
 - b. Cermak Health @JTDC: Provide mental health services to youth within the JTDC and linkage services to those leaving the JTDC
 - c. CPS-Juvenile Justice Team: Support student transition from Nancy B. Jefferson in juvenile detention back to CPS schools—both district and Options (alternative schools)
 - d. CCH Continuity of Care Program: Connect youth to CCH and community based behavioral health services in order to help youth and their families navigate the health care delivery system
 - e. Cook County Juvenile Probation: Provide services to pre-trial youth in detention and probation youth in detention.
