- a. Updates on JTDC Population
  - i. Total Population: 169; 34 AT, 135 Juvenile
- b. COVID19 Updates
  - i. 103 Staff Members and 83 Youth have tested positive
  - ii. No new youth tested positive during the month of February
- c. Updates from Board Members

**III.** Presentation by Lisa Hampton, Samantha Edwards and Rebecca Estrada of DFSS:  
The SCAN Model

- a. SCAN Model
  - i. Goal: Reduce violence and recidivism
  - ii. Started pilot year (currently 3 months in)
  - iii. 6 neighborhoods in Chicago; 13 delegate agencies
  - iv. Serves youth and young adults aged 14-24 that reside in 6 community areas
  - v. Eligibility: Within past year, must meet at least one in criteria category 1 and at least one in criteria category 2
  - vi. Plan to serve 48 youth in first year
  - vii. Each youth has a navigator assigned to them (Navigators have a maximum capacity of 16 on caseload)
  - viii. Can be served by program for as long as needed to achieve goals
  - ix. Can provide ancillary supports to youth as needed (flexibility in funding)
  - x. Questions:
    - 1. In terms of data is City Span still the central reporting tool? If so, how do you share information with partners
      - a. They will get data in contract management meetings. Shared data will go through Harvard GPL.
      - b. No risk assessment to avoid risk assessment burnout; however, use case planning tool for goal setting

- c. Violence reduction dashboard-may have data on number of eligible youth
  - 2. What would tell you that you are on the right track? What models or other organizations have informed your program?
    - a. April until November 2019 interviewed folks from across US (New Jersey, Oakland Justice Hub, Philly Justice Hub, LA, PACE FL, etc.) and locally (READI, CRED, New Life, etc.)
    - b. Not looking at is as a “model”
    - c. Want to make space for LGBTQ+ and Gender-Responsive work, so took out “gun violence” and included youth at risk of all violence
    - d. North Star=reduction of violence
  - 3. Hopes after pilot?
    - a. Are the referral sources doing due diligence to find the right kids? Best referral sources?
    - b. Are we addressing gender responsiveness?
    - c. Are we doing technical assistance with navigators in the field? How do we hire right kind of person?
    - d. Department moving away from outputs and more toward outcomes.
