F. Introduction of New Department Staff

Human Rights Commissioners and DHRE staff introduced themselves.

G. Director's Report

- Director King provided updates on FY25 Q2 with two-thirds of the quarter complete. The number of cases pending at all stages has increased from the last quarter. 251 new inquiries, 44 new cases filed, 23 cases closed which is an increase from 19 closed last quarter. 5 cases settled thus far, increase from the 1 case settled last quarter. Known settlement of \$2,375.
- Policy: Cook County Board of Commissioners approved the proposed amendments to the Cook County Paid Leave Procedural Rules on April 10, 2025. The approved rule amendments are available here: Paid Leave Ordinance and Regulations. On March 13, 2025 the definition of "national origin" within the Human Rights Ordinance was amended including but not limited to associated physical, cultural or linguistic characteristics aligning with the State and City definitions. The Commission on Human Rights is working on related guidance for potential instances of discrimination. The Roosevelt University Just Housing Amendment Impact Assessment closed on April 30, 2025. On April 10, 2025 Item # 25-2344 was introduced to the Cook County Board of Commissioners. The Resolution asks the Commission on Human Rights to present at an upcoming hearing on May 14, 2025 regarding the Wage Theft Ordinance, which the Commission is not the enforcement agency of, but the Commission will testify regarding other labor related complaints that we received.
- Outreach: One of the Outreach and Training coordinators provided updates on events and trainings attended to continue departmental efforts to spread awareness of Cook County Human Rights and Ethics ordinances and protections. Specifically, highlights on the Removing Barriers panel discussion that the Commission hosted on April 22nd in honor of Fair Housing and Second Chance month regarding the impact of the Just Housing Amendment to the Human Rights Ordinance. Highlight on the Commissions expansion of their outreach capabilities regarding language access by providing a worker protection training in English, Spanish and Mandarin. The Commission is currently preparing materials for the July 2025 Minimum Wage updates, an ordinance the Commission enforces. Human Rights newsletter increased to 2,305 subscribers.
- Intention to revitalize the Commission Workgroups. More information regarding structure and goals will be shared with the Commission via email.
- Chair and Vice Chair elections will take place at the next Commission meeting on July 17, 2025.
