# Financial Tools and Incentives Subcommittee-Pam McDonough

Financial Tools and Incentives subcommittee recommended action on the following projects:

<u>Meeting Tomorrow Properties, LLC, 2901 West Lawrence Avenue Chicago, IL-Application for a Class 7b incentive</u>—The applicant intends to substantially rehabilitate and repurpose the property to enable it to move its technology solutions business operations to subject site. There was open discussion regarding the project. Motion and second for approval. The item was approved. Chris Jang and Simone Weil abstained from the vote.

<u>South Lafayette Self Storage</u>, 8522 South Lafayette, Chicago, IL- Application for a Class 7b incentive — The applicant intends to redevelop the site for two users, a self-storage facility and charter school. There was open discussion regarding the project. Motion and second for approval. The item was approved. Robert Tucker, Rob Rose, Chris Jang, Simone Weil abstained from the vote.

Adams French Property LLC, 7421 North Waukegan Road, Niles, IL- Application for a Class 7b incentive—The applicant intends to construct a four story self-storage facility on the site. There was open discussion regarding the project. Motion and second for approval. The item was approved. Simone Weil abstained from the vote.

100 West Golf LLC(Napleton Mazda and Subaru), 1775 North Rand Road and 1801-1815 North Rand Road, Palatine IL-Application for a Class 7c incentive—The applicant intends to relocate and expand its business to subject property, where it will construct two new automobile sales and service facilities. There was open discussion regarding the project. Motion and second for approval. The item was approved. Simone Weil abstained from the vote. Howard Males recused himself from the vote.

Rawls Roads Properties LLC (Sam Jidd Luxury Auto Dealership), 105 South Mount Prospect Road, Des Plaines, IL-Application for a Class 7c incentive- The applicant intends to substantially rehabilitate and lease the subject property to a car dealership. There was open discussion regarding the project. Motion and second for approval. The item was approved. Simone Weil abstained from the vote.

#### President Toni Preckwinkle, Presentation

President Toni Preckwinkle presented an overview of the Policy Roadmap. The vision of the Policy Roadmap is to be a leader in building vibrant, sustainable and inclusive communities where people want to live, learn, work and play. The six policy priorities center on: health and wellness, economic development, environment and sustainability, good government, public infrastructure and criminal justice improvements. The President emphasized the importance of and focus on alleviating inequities in the County as a means to improve economic conditions. There was open discussion on the Policy Roadmap and general comments on work of the County going forward.

#### Planning and Development Subcommittee-Andrew Geer

Planning and Development Subcommittee recommended action on the following projects:

<u>CDBG Substantial Amendments for 2015 and 2018</u>-Calumet Collaborative for planning/capacity building to support storm water and adjacent redevelopment potential, Village of Posen for sidewalk improvements, and City of Markham for infrastructure improvements. Motion and second for approval. The item was unanimously approved.

<u>2017 Program Year Consolidated Annual Performance and Evaluation Report (CAPER)</u> –Item is to be submitted December 2018. Motion and second for approval. The item was unanimously approved.
